POSITION SUMMARY

Maintain and organize the work flow and producing product in the Lathe area of Machining department.

DUTIES AND RESPONSIBILITIES

- Studies blueprints, manuals, specifications, or sample parts to determine dimensions and tolerances of finished workpiece, sequence of operations, and setup requirements.
- Runs lathe machining center, including but not limited to, prepping parts, loading parts, starting and observing machine operation to detect malfunctions or out-of-tolerance machining, adjusting machining controls, and unloading parts.
- Performs first-piece and in-process inspection by checking dimensions of part per blueprint using calipers, micrometers, indicators, and tape measure.
- Provide Technical guidance as needed
- Assist in development of Standard Operating Procedures (SOP) and new processes.
- Work with Plant Superintendent to identify areas of Continuous Improvement.
- Operate forklift to move and organize product.
- Assure machining area is kept organized.
- Other tasks and duties as assigned.
- Maintain compliance with all work rules (productivity, conduct, safety, etc.).

The Lathe CNC Machinist position has a direct and significant impact on the day to day operations of the machining department.
